Project Coordinator report (Dave Mueller) – 2023 treatment plan.

2023 was a good year for aquatic plant growth across the county including native and EWM. Yellow Birch has approximately five acres of EWM in the northeast bay with some of the EWM appearing above the surface. There is a similar situation on Catfish Lake in the old Twelve Pines Bay which was not included in the September 2022 survey for hand harvesting in 2023. It was added in July 2023 for additional hand harvesting.

Onterra will be presenting the overall AIS picture and strategy at a meeting in the Washington Township Hall on November 15, 2023.

Expect 15 days of harvesting in 2024.

A discussion was held regarding AIS strategy, future DNR grants, and a communication strategy to make the chain landowners aware of the situation. The Commission will meet again on November 2 to review AIS strategy options going forward.
