Eddie Heath, Lake Ecologist with Onterra, LLC, delivered a presentation on results of the 2017 Eagle River Chain AIS project and preliminary 2018 management strategy.

Mueller discussed the 2018 management approach. Estimated cost \$34,000 - \$37,000 in 2018. Hand harvest utilizing DASH in 3 locations is anticipated. Anticipated private sector cost \$6,467.

Mueller distributed and discussed the WDNR ACEI-144-14 grant funding projection indicating grant funds will probably be exhausted in 2019. Copy of said report is attached to these minutes. A request to extend the grant end date of 12/31/17 for one year has been made to the WDNR. It is anticipated another request for extension will be needed in 2018.

There were no reports from Project Coordinator, Public-Private or team member reports.

Kevin Gauthier, WDNR Water Resources Management Specialist, stated Wisconsin administrative code relating to grants is being revised with completion in 2019.

Favorite stated the Unified Lower Eagle River Chain of Lakes Commission was formed in April 2007.
